The Highland Township Board of Supervisors (BOS) met on this date at 6:45 p.m. immediately following the organizational meeting as publicly advertised, at the Highland Township Municipal Building, 3641 Fairfield Road, Gettysburg, PA 17325.

POLICE, FIRE AND RESCUE

The following reports were reviewed: PA state police (Nov), Cashtown and Gettysburg Fire Dept (Dec)
